

2017 CAMPGROUND RESERVATIONS DUPAGE COUNTY FAIR – July 26 - 30 Wheaton, Illinois

Due to the growing demand for camper parking area and limited space changes have been made.

Reservations will be honored of a first received first considered in the following order:

- **Food vendors**
- **Commercial exhibitors**
- **All others**

1. All camper sites will be for LIVING QUARTERS ONLY. No storage trailers. No lounging areas and no awnings.
2. Reservations will be for the campground and not a specific site.
3. **Campers will be parked by THE representative of the Fair and no one is allowed to park themselves.**
4. **All campers must submit an application for the campground no matter what other applications have been submitted (No application No site).**
5. **A \$50 deposit will be required at to time of application and will become non-refundable once the application has been accepted.**
6. Camper Placement (parking of campers) times
 - **Sat-Sun, July 22-23: 12:00noon until 5:00PM (No guarantee of grey water)**
 - **Mon-Tues July 24-25: 12:00noon until 6:00PM**
 - **Early or late will have to wait in West parking lot outside of fence.**
 - **Early or late contact Camper Parking Person!**
7. The camping fee will be computed by the square foot based upon the square footprint of the camper (see application). If size is incorrect on application, you will be responsible the extra fees. There will be minimal space between campers.
8. Parking for vehicles other than campers will be limited to specific areas away from campers (Not necessarily in the campground).
9. **Generator will be operating starting Monday at 4:30pm,** and grey water service Monday 9:00am. Both are included the daily fee. WASTE WATER DUMPING IS NOT ALLOWED ON THE GROUNDS. THERE WILL BE A SERVICE AVAILABLE FOR A “FEE” TO REMOVE WASTE (Black) WATER. (Daily Fee is charged from day one without water & electricity until Monday.)
10. NO PARKING IN FIRE LANES.
11. Reservations will be honored until **6:00 PM on Monday, July 24th**, unless other arrangements have been made with THE REPRESENTATIVE OF THE FAIR.
12. Campers that will be removed prior to the Monday following the Fair must get prior approval from THE representative of the Fair.
